Per our conversation from this morning, we need to arrange a polygraph of Jennifer Wescott to confirm the information she provided us the other day, and to see if she has any additional information. (I don't question his ability, but I'm trying to anticipate defense arguments and avoid issues.)

While talking with Chief Orlo Green this morning, I asked if his department would assist on a polygraph. He said that they would help in any way, and he mentioned that Mike Curtis and Aimee May are both able to conduct polygraphs.

Please make arrangements to have the polygraph performed as soon as possible.

As we discussed this morning, we also need to make interviewing Tracy Breckenridge a top priority, and I have some information that may help you find her.

In looking through prison records for Roger Breckenridge, Mark was able to find the following information for the children of Roger and Tracy Breckenridge. Perhaps Tracy lives with one of them, or at least they might know how to reach Tracy.
